Terms & Conditions - Player / Parent / Guardian / Caregiver

By registering with BUFC Inc in the Squadi online registration system you are accepting the Club Rules/Terms and Conditions.

You agree to and are aware of the following:

I agree to the Terms & Conditions of Bluebirds United Football Club Inc relating to the Club, Member, Player, Parent and Spectator Policies and subsequent Codes of Conduct including those of Football Queensland and other related affiliations.

I agree to allow photographs of myself or my child/ren to be used in the Bluebirds United Football Club's public print and online media platforms. In certain circumstances your photo may also be used by governing bodies such as FQ for instances such as talent identification or promotional events. In such cases only first names will be used, unless preapproval is given.

***Online and print photo opt out** – If you do NOT want photographs/videos of you or your child/ren to be used in the Bluebirds United Football Club's public print and online media please indicate your objection by completing the Club's media form below.

I understand that Bluebirds United Football Club Inc. online registration process requires you to provide a range of personal information e.g. name, birth dates, addresses etc. This information is required for registration, membership & volunteer purposes with BUFC Inc & other governing bodies.

I understand full names, emails and phone numbers will be used on BUFC team lists to assist coaches & managers in the organisation of teams. Only members of the executive will have access to your full registration information.

I understand as per the refund policy of the club, refunds are solely at the discretion of the committee. All decisions regarding refunds will not be processed until after the next applicable management committee meeting. The club reserves the right to deny playing time to any player who is not financially current at the commencement of a fixture. For the avoidance of doubt, financially current represents a fully paid player.

I understand at the discretion of the management committee, Individual/s or teams, whichever is the case, are liable to pay any disciplinary fines handed down by FQ. This includes coaches and spectator fines.

I undertake to provide the BUFC with any information relevant to the wellbeing of my child/ren prior to them attending any and all scheduled activities. I give permission for the personal details given to be provided to coaches, managers, other officials and/or relevant medical/emergency services as deemed necessary.

I understand that every effort will be made to provide a safe environment, however in signing this form I authorise coaches, managers, or other officials, in the event of an emergency, to obtain at my expense any medical, ambulance, or other services considered necessary.
